**DEED OF VARIATION OF
SUPPLEMENTAL FUNDING
AGREEMENTS**

THIS DEED is made the 30th day of September

2019

BETWEEN

- 1) **The Secretary of State for Education of Sanctuary Buildings, Great Smith Street, London, SW1P 3BT (the "Secretary of State"); and**
- 2) **The Bay Learning Trust a charitable company incorporated in England and Wales with registered company number 07588464 whose registered address is at The Lodge Ripley St Thomas CE Academy, Ashton Road, Lancaster, England, LA1 4RR ("the Company")**

together referred to as the "**Parties**".

INTRODUCTION

- (A) The Parties entered into a supplementary funding agreement in respect of Ripley St Thomas Church of England Academy dated 23 May 2017, a copy of which is contained in Schedule 1A (the "**Existing Ripley SFA**");
- (B) The Parties entered into a supplementary funding agreement in respect of Carnforth High School dated 24 May 2018, a copy of which is contained in Schedule 1B (the "**Existing Carnforth SFA**");
- (C) The Parties have agreed to amend and re-state the terms of the Existing Ripley SFA and the Existing Carnforth SFA on the terms set out in this Deed.

1. INTERPRETATION

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with the Existing Ripley SFA and the Existing Carnforth SFA.

2. VARIATION

IT IS AGREED as follows:

- 2.1 The Secretary of State and the Company agree that with effect from the date of this Deed, the Existing Ripley SFA shall be amended and re-stated in the form of the Amended Ripley SFA set out in Schedule 2A (the "**Amended Ripley SFA**"). For the avoidance of doubt, the Amended Ripley SFA does not terminate or suspend the Existing Ripley SFA but amends and re-states it.

2.2 The Secretary of State and the Company agree that with effect from the date of this Deed, the Existing Carnforth SFA shall be amended and re-stated in the form of the Amended Carnforth SFA set out in Schedule 2B (the "**Amended Carnforth SFA**"). For the avoidance of doubt, the Amended Carnforth SFA does not terminate or suspend the Existing Carnforth SFA but amends and re-states it.

3. GOVERNING LAW AND JURISDICTION

3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with the law of England and Wales.


3.2 The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

3. COUNTERPARTS




